Call for Papers

<u>Professional Papers</u> | <u>Student Papers</u> (electronic recipients of the Newsletter can click on these)

Behavioral economics is a major innovation to the economic way of thinking, which it brings closer to psychology, sociology and the neurosciences. The conventional economic paradigm was based on extreme assumptions of stable preferences, perfect rationality and tight market equilibrium. By their simplicity, the latter have allowed economists over many decades to derive testable implications for individual behavior and market outcomes. However, other social scientists and a minority of economists questioned these assumptions and developed different approaches. For some time, economic psychology has been a forum for psychologists who studied economic behavior, like market exchanges and saving, with their own tools and methodology; and behavioral economics has been a forum for non-conventional economists who were open to the knowledge produced by neighboring disciplines. However, the increasing use of controlled experiments and real data is now transforming behavioral economics and economic psychology into a mainstream line of research. Whereas the field's growth was initially boosted by the discovery of paradoxes and anomalies to the conventional economic approach and still is, the time has also come to develop alternative theories and sort out the rival assumptions.

The SABE Conference aims at providing a platform to the fast growing number of economists, psychologists, neuroscientists and other social scientists who wish to discuss, rigorously but open-mindedly, their latest research in this emerging field. Relevant topics include all domains in which tenets of economic theory have been seriously and systematically challenged:

Experimental economics and neuro-economics; bounded rationality, learning and preference formation; choice under uncertainty and over time; reciprocity and social preferences; satisfaction, happiness and emotions; the psychology of economic behavior; applications of behavioral economics to finance, consumption and saving, game theory, industrial and labor relations, public economics, health, education, organizations and institutions, etc.

Submission Invitation:

Individual papers/posters and proposals for sessions (which should include 4 papers per session) are invited. Papers and sessions may be related to any area of behavioral economics and/or economic psychology. Theoretical, empirical and experimental contributions are welcome. Proposals may emanate from economists, psychologists, social scientists and neuroscientists provided they remain accessible to scientists from other disciplines.

Submission Items and Deadlines: Informative abstracts (3000 to 5000 characters, with goal, hypothesis, method, results, conclusion...) of proposed papers/posters and proposed sessions should be submitted online, BEFORE March 15, 2007 to Prof. Douglas Rebne - drya@nyu.edu for evaluation for inclusion in the program. Acceptances will be issued by March 31st. Complete papers should be submitted online by May 7 at the latest for inclusion in the proceedings. The *maximum* word limit is 10,000.

Keynote Speakers

SABE Keynote Speaker - Edmund S. Phelps



Edmund Phelps joined the Department of Economics at Columbia in 1971 after several years at Pennsylvania and earlier Yale. He was named McVickar Professor of Political Economy in 1982. He is the 2006 winner of the Nobel Prize in Economics.

Phelps's work is best known for introducing in the late 1960s an expectations-based microeconomics into the theory of employment determination and price-wage dynamics. Keynes's great work of the '30s had left it unexplained why involuntary unemployment is observed even in the best of times and why a drop of aggregate "effective demand" causes a rise of unemployment

- why not a prompt fall of money wages and prices by just enough to forestall a fall of employment? The challenge was to resolve these issues while continuing to posit the elementary rationality that economics traditionally ascribed to workers, consumers and firms.



Since October 2000, Rainer Plaßmann has served as Secretary General of CEEP (European Centre of Enterprises with Public Participation and of Enterprises of General Economic Interest). He previously . He previously trained as an attorney, Mr. Plaßmann worked as a legal advisor to Stadwerke Köln GmbH, eventually heading the legal department as well as the department of "Central Executive Board and Supervisory Board Affairs, Strategic Group Planning, Organisation and Press".

Graduate Student Paper Competition

Following the ballot of the SABE Membership there will now be a formal graduate student paper competition. The arrangements covering graduate students are:

- 1. All graduate students are registered at a discount rate.
- 2. As many as three graduate student papers will be selected each year for the award.
- 3. Prize package: (i) a one year free subscription to the Journal of Socio-Economics, and (ii) a cash prize of \$1000.
- 4. A Graduate Student Paper Evaluation Committee will be appointed by the President. This Committee will have three members.
- 5. Any student paper if deemed of merit by the Committee may also be entered in the competition.
- 6. Papers written solely by the student will be favored, although papers having faculty as a secondary author(s) will also be considered.
- 7. The *Journal of Socio-Economics* will consider the winning papers for publication unless the author (s) declines.

SABE-CEEP European Doctoral/Post-Doctoral Fellowship

Rainer Plassmann's European Union body (CEEP) are willing to offer a one-year doctoral/post-doctoral fellowship to be administered by SABE. The position will offer a monthly stipend of approximately \$1600 as well as furnished lodging in Brussels. Travel around Europe in support of CEEP's research interests will be paid for as well. The work is broadly conceptualized--essentially policy-oriented research concerned with the socioeconomic impact of public-private and public economic activity--and should easily blend with the interests of any behaviorally-oriented economics student who has an interest in matters comparative and international. A further description is expected and the general plan is that Rainer Plassmann would meet with candidates in NY on May 18th and a final selection would be made soon after.

Letter from Ben Gilad to John Tomer, January 1983

Simon: Wow, what a blast from the past (sorry, an American expression). Of course you can reproduce the letter. I can't even recall its circumstances any more, or the meeting it reflects, but I do recall Shomo Maital (I am sure you know him) and me deciding to go ahead and form SABE.... It is heartening to see some of my old colleagues, like John Tomer and Roger Frantz still involved in SABE. Talk about persistence. When I left the field of Economics, I lost track of those guys. Do give them my warmest regards, if you see them or talk to them. Yours, Ben Gilad

January 6, 1983

Dear Professor Tomer:

On December 29th we held a meeting to discuss the possibility of establishing an organizational framework for behavioral economists. The meeting was attended by 14 people whose names and affiliation are listed on the following page. The discussion at the meeting concentrated on two points: First, the scope of behavioral economics, and second, the need for a formal organization. No consensus was reached on either point with some participants arguing for the inclusion of a wide spectrum of behavioral-social sciences in behavioral economics and some favoring the narrowing of the scope of only the psychological aspects of decision-making. On the need for a formal organization the opinions ranged from a reluctance to have more than an informal mailing list to a call for the establishment of a formal association which will promote the interdisciplinary issue within the economic profession. At the end it was decided that the participants should write down their thoughts regarding the scope of behavioral economics and the purposes(s) of an organizational setting. The participants agreed to send it to me as soon as possible to see if a compromise can be reached at this point on these matters.

The last topic agreed upon in the meeting was the proposal to prepare the ground for a conference on behavioral economics. These preparations will include a mailing campaign (to be arranged by Jay Schmiedeskamp and me) to potential contributors and participants to assess the interest in such a conference and to estimate the extent of the research currently going on in the field. The Journal of Behavioral Economics agreed, in principle, to publish the proceedings of such a conference and the Economics Department at Rutgers University agreed, in principle, to host.

I would be happy to hear your comments about these matters.
